Site leadership ensures that all stakeholders are engaged in the development the ESSER Elementary and Secondary School Emergency Relief. The non-profit governing board, School Site Council (SSC), District English Learner Advisory Committee (DELAC), Administrators, Principals, Teachers, Staff, Parents, Students, and Community Pupils were all provided opportunities to provide feedback and make suggestion to ensuring plans and actions benefit all students.

Public Hearings were held on July 20, 2021, with the DELAC, Parent Councils and School Site Council. Public hearing was held on August 9, 2021, with the Agape Board of Directors. Notifications were provided to all stakeholders in accordance with the law. In separate meetings, the Agape Board of Directors, School Site Council, District English Learner Advisory Committee met to receive

and discuss survey data collected from stakeholder. Within the meetings the Boards also reviewed student academic achievement and performance data and contributed their own input to the continuation of program improvement Parent comments from the public hearings were incorporated into this ESSER. Also, within the meeting and public hearings, the Boards discussed how funding will be allocated to service students with disabilities, English Learners, Foster and Homeless youth. The input received provided additional aspects into upcoming LCAP and ELO initiatives to better serves all students. The LEA conducts a needs assessment to identify the needs of the school, students, and teachers. Along with the newsletters, informational parent letters, school messenger notices and informational meetings, all stakeholders were given the opportunity to view annual comprehensive survey and needs assessment items to give feedback on the multiple aspects of operations at DuBois. Items included initiatives regarding EL Learner, College & Career Readiness, Instructional Strategies, Campus Culture, Student Safety, Instructional Materials, Teacher Support, Rigorous and Relevant instruction, Homeless and Foster Youth Policy, Parent Compact, and Staffing needs.

The goal is to identify the proper resources, learning opportunities and supports to ensure needs are met to promote on-time graduation for all students. Staff will be provided with professional development with social emotional learning (SEL) strategies, student engagement and higher order thinking skills to reduce chronic absenteeism for students, increase academic interest, reduce credit-deficiency, and coping mechanisms for their personal and professional needs to increase instructional time and reduce learning gaps. In the case of future school closures, we will use our multi-Tiered levels of support for our students and provide personalized student support services for all students. To ensure students with disabilities and English learners are met, we will be prioritized technology rollouts, one-on-one and small group instruction (via Zoom or in person) and any other resources necessary for continued success. In addition, school counselors will work teachers and support staff by providing additional support with meeting the social and emotional needs that may require services with consulting therapist and contracted district psychologist. All procedures will be available to all stakeholders for maintaining a safe and secure work and learning environment to reduce loss of learning due to mental, health, social economic status barriers and designation such as EL, homeless, foster and at-risk students.

Additional support and supervision will be provided to students with disabilities including extended learning opportunities with the After-school program, enrichment, and health and wellness programs. Our nutrition program from the food service department will provide breakfast, lunch and snacks to students receiving instruction in-person, hybrid (if applicable) and distance learning (if applicable) ensuring student's health and nutrition needs are met during the academic year.

The School Site Council/DELAC and Parent meetings impacted the ESSER by giving key stakeholders the opportunity to become familiar with the ESSER goals and actions. The community input ensured that all goals and actions were aligned to the LCAP and the contents of the SPSA for the site. Additionally, the Boards reviewed how data is used as a major influencer for addressing areas needing improvement and worked collaboratively to discuss solutions and interventions that need to be refined immediately and for the upcoming academic year. Stakeholders provided input through surveys, public comments, electronic correspondence, and community meetings.

 extended day, comprehensive afterschool programs, or extended school year programs.
